Note: Forms for small business claimants must be **submitted by the end of each Quarter** with the final cut-off date of 30 June 2025 for the 2024-25 Commonwealth Government Energy Rebate for Small Businesses. Applications for embedded network claimants submitted after 31 December 2025 will be considered on a case by case basis.
